INTRODUCTION / DISCLAIMER

This document was developed in 2024-2025 for the purpose of compiling and organizing the different Local Laws adopted by the Town of Clermont, NY into a codified town code structure which could serve as reference to local officials and allow the adopted laws to more accurately reference one another where applicable.

The Local Laws compiled here were collected via the New York State Department of State online Local Laws Search tool (https://locallaws.dos.ny.gov/). The New York Department of State maintains this electronic database ("Local Laws Database") which have been filed with the Department of State on or after January 1, 1998. Local Laws Database, but are maintained in manual paper files instead. As such, this document is not a complete collection of all Town Laws, nor considered an "official" or "certified" search by the Department of State, and it is unknown how complete it is.

It is anticipated that this document will be further developed in the future as the Town of Clermont is able to request and obtain copies of ALL laws on file as part of an officially certified records request, and each can be transcribed herein. Until that time, each Local Law compiled here has been provided in its original scanned filing format for reference purposes only.

FORMAT / ORGANIZATION

The code structure developed organizes the various local laws into Parts, Chapters, Articles and Subsections. To reserve and leave space for additional or future laws, the Chapters have been numbered to leave unused or empty spaces for future use.
